### **Rules Of Order**

- 1) Every sitting of the Meeting of the Association Body of Delegates shall be opened and closed with prayer.
- 2) Adequate time shall be allotted in the opening session for a devotional.
- 3) Persons invited to a seat may speak on all subjects under debate, but would have no vote.
- 4) Every speaker shall address the Chair and shall identify themselves and their Church.
- 5) No person shall speak for more than three minutes on any subject without permission of the Body.
- 6) No person shall speak more than twice on any subject without permission of the Body.
- 7) Motions made and lost shall not be recorded in the Minutes unless so ordered at the time. When the Motion is not recorded, the Minutes shall note the subject of the discussion.
- 8) The government of the Body and the regulations of its proceedings shall be strictly in accordance with parliamentary usage so called.
- 9) When a Church is received into the membership of the Association the Moderator shall give the "Right Hand of Fellowship" to one of its Delegates.
- 10) At the commencement of each session, except the first, the Minutes of the previous session shall be presented and approved, and the Minutes of the final session shall be approved by Council.
- 11) Resolutions shall be presented in writing when so desired by the Moderator or the Clerk.
- 12) Immediately after the opening of the Meeting these rules shall be distinctly read by the Clerk.

### HRUBA Minutes AGM 2021

HRUBA Annual General Meeting (via Zoom) Hosted by First Baptist Church Halifax **Tuesday, April 20, 2021 @ 7pm (Chat at 6:45 pm)** 

1. Dave Gibson, HRUBA Constitution Chair and member at 1<sup>st</sup> Baptist, Halifax, went over the rules for Zoom voting and informed the viewers that the meeting would be taped for recording minutes.

2. Welcome ~ Ann Taylor, HRUBA Moderator and member of Bayers Rd Baptist, welcomed everyone and spoke about the passing of HRUBA Treasurer, (served 4+years) Debra McGaw. HRUBA Council made a donation to Bethel Baptist Church in her memory.

3. Devotional time and opening prayer led by Rev Dr Rusty Edwards, pastor at 1<sup>st</sup> Baptist Church, Halifax. Rusty read part of a poem entitled "They have threatened us with Resurrection", by Rev Julie Eskival, Presbyterian pastor and human activist, serving in Guatemala. The disciples thought that the word being spread about Jesus not being in the tomb were rumors. Peter cared enough to check. What he found was "Transformative Hope"; that resurrection was certain!!! We are all given "transformative hope with the threat of resurrection". When we, the church of Jesus Christ, come through this Pandemic, may we be more committed to helping/transforming our community. May we all live with the threat of transformative hope. Amen

4. Rules of Order read by Lee Nicholas-Pattillo, HRUBA Council member at large, on Advisory team and member of 1<sup>st</sup> Baptist, Halifax, and she was timekeeper as well. (3 minutes to speak on any matter on the floor with 30 second warning; 5 min presentations with 1 min warning)

8. Vote to receive God's Army Community Fellowship of Eastern Passage to our family of churches: Rev Dr David Watt, Interim pastor at Bedford Baptist Church, member of West End Baptist, made a short presentation about GACF. Over the past year West End Baptist has been their mentor. This group started out as a small Bible Study and have grown to 50 members and 7 children with an average of 42 to 65 in attendance most Sundays, even in the Pandemic. West End will continue to walk alongside GACF in the months and years ahead. Please pray for them as they look for a permanent place to worship. 2) has given satisfactory evidence of meeting the requirements for membership as laid out in Section 7.2: Joining of the Association's By-Laws; and

3) West End Baptist Church has acted as a mentoring church for the past year and has recommended God's Army Community Fellowship for membership; and

4) notice of intention to put this resolution to the vote was given at the March 7, 2020 Meeting of the Association Body of Delegates; and

5) a quorum of members of the Society is present at this Annual General Meeting of the Society;

#### THEREFORE:

BE IT RESOLVED as a SPECIAL RESOLUTION of the members of the Society that: God's Army Community Fellowship be admitted into the membership of the Halifax Region United Baptist Association.

This motion was moved by Rev Dr David Watt and seconded by Rev Dr Frank Guinta. Floor open for discussion or comment; hearing none, Ann Taylor, asked for show of hands in favor; opposed, none; Motion carried unanimously. Ann Taylor, Moderator declared special resolution passed.

GACF was warmly welcomed into the HRUBA family of churches. Special thanks to Pastor Jason Cole of Regal Heights for all his help with GACF. Rev John Purdy, HRUBA Home

Missions Chair and pastor at St Margaret's Bay and Birchy Head Baptist Churches, prayed for GACF.

9. Motion to approve the AGM Minutes of Saturday, March 7, 2020 as distributed, moved by Rev Greg Drummond, Bayers Rd Baptist Church; seconded by Rev Deb Stevens, Foundation Baptist Church. Ann asked for errors or omissions; hearing none, asked for show of hands in favor of motion; opposed, none; motion carried.

10. Linda Crilley, Timberlea Baptist Church, HRUBA Financial Advisor, moved that the body receive all other printed reports excluding Finance/Budget, Licensing and Nominating; seconded by Rev John Purdy. Any discussion, questions or concerns about any of these reports; hearing none; Ann asked for a show of hands in favor; opposed, none; motion carried.

11. Finance/Budget report and vote: (Financial Report should read 2020, not 2019, at top of page)

Linda Crilley presented the Financial statements of 2020. Thanked the HRUBA family of churches for their support during the pandemic. It was pointed out that Mulgrave Park should be removed from the Dues page of the reports, moving forward.

Linda moved the report, as found in the report book; seconded by Pastor Kevin Jolly, Aurora North End Parish Church (formerly Mulgrave Park); discussion or questions; hearing none, Ann asked for show of hands in favor; opposed, none; motion carried.

Linda also presented the 2021 Budget. No change to dues for 2021; still \$16.00 per member. Budget much the same as 2020. Linda moved the adoption of 2021 Budget; seconded by Rev Deb Stevens; any discussion, questions or concerns; hearing none, Ann asked for show of hands in favor; any opposed, none; motion carried.

#### 12. Licensing Report and vote:

Rev Darren Millett, New Life Community Church, Chair of Licensing Committee, presented the reports from the Licensing Committee found on pages 22 and 23 of the Annual Report Book

~Association Licenses to Minister for Darian David, Faith Baptist, and Andrew Sutherland, Birch Cove Baptist

~Renewal of Lay Licenses to Minister for Kathy Cochrane, Bedford Baptist, and Peter Freeman,  $1_{st}$  Baptist, Dartmouth

Darren moved the report; seconded by Rev Nelson Metcalfe, Pastor Emeritus, Bedford Baptist Church; Ann called for discussion; hearing none; called for show of hands in favor; opposed, none; motion carried.

#### 13. Nominating Committee Report:

Rev Dr Frank Guinta, Vice Moderator, Chair of Nominating Committee, presented the 2021 Nominating report found on page 24. Ann asked for further nominations; hearing none; asked for motion. Frank moved the report with the request that Council Executive be allowed to fill vacancies to be ratified at the next AGM; seconded by Pastor Jason Cole; Ann asked for any discussion: it was mentioned that there are key positions to be filled – Vice Moderator, Treasurer and Clerk; asked if Ann was filling the position of clerk? Only interim!!! No more discussion; Ann asked for show of hands in favor; opposed, none; motion carried.

14. Discussion and vote on By-Law changes.

Dave Gibson, 1<sup>st</sup> Baptist, Halifax, Chair of Constitution Committee, presented the By-Law changes with a bit of history and explanation for making these changes. It was noted that these changes were emailed to the HRUBA family of churches with a covering letter, giving individuals and churches the opportunity to ask questions through email or Zoom meeting. ### **HRUBA Moderators Report**

For the 2021 Fiscal Year

A personal emphases on "Spiritual Formation" has been my devotional quest this past year. Having a deep desire to go deeper into my discipleship process has had the focus of defining my ministry calling, in these senior years of my life. The foundations for this have been Matthew 28:18-20 seeking to experience the Holy Spirits unction as described in Acts 1 and 2. Added to this, it is a joy to express deep gratitude for the way our churches have financially supported this ministry. The gifts and dues extended to the Association have placed us in a solvent position that has enabled us to fulfill our responsibilities with integrity. Please take note of the balance sheets and confirm a sincere hallelujah for how God in all his richness has blessed us. The council has been more than aggressive in fulfilling their ministries and I also extend my gratitude to the efforts they make to activate their ministries during these difficult times.

Coming soon will be a notice that the Association will be sponsoring a major leadership assembly on the theme "**The Season of Decline:** God's Occasion to Renewing the Church for New Life". Arrangements are being made, leadership engaged, and venue reserved. Formal notices will be sent to you soon in this regard. ### Halifax Baptist Chaplaincy Committee Report

For the 2021 Fiscal Year

COVID-19 had a dramatic effect on this ministry in 2020, with reduced hours for our chaplains and reduced budget to support the ministry, although financially we came out "in the black" at the end of 2020 due to very strong support from our churches.

For 2021, we were back to being fully staffed (Adele full time and Ida 12 hours per week) with a full expenditure budget and somewhat reduced income budget for a small anticipated deficit at year end (see below). The continued support of the HRUBA (chaplaincy in the yearly budget), Atlantic Baptist Foundation (\$10,000 grant) has been fundamental to continuing this ministry. These two sources give us an assured source of income while waiting for donations from local churches that support our Chaplaincy. Once again this year we sent a letter of thanks and a request for continued support to the CABC churches in Nova Scotia. There was a good response in November and we await the year-end report from the CBAC office with the December donations.

For now we are in a good financial position, with a surplus from the last several years giving us a working reserve. We are also working on getting an endowment fund set up to provide an additional means of supporting the chaplaincy for those wishing to make memorial or other donations. This will be done through the HRUBA banker.

This year, we were happy to welcome the Rev. Joseph Green to our committee. Joe brings a the background of a local pastor and experience as part-time Director of the Taylor Centre for Chaplaincy and Spiritual Care at Acadia Divinity College, which will certainly add to the perspective of the committee. We can still use more members on our committee, which meets most months to provide support to our Chaplains and oversee financial support for the Hospital Chaplaincy.

Planning for the retirement of our full time chaplain, the Rev. Adele Crowell in June, 2022 is progressing well. A Personnel Sub-Committee has been established and it has revised the Job Profile for the full-time Chaplain. The May 4, 2011 Halifax Baptist Chaplaincy Policy Manual has been extensively updated to create a new Halifax Baptist Hospital Chaplain Personnel Manual.

The Sub-Committee produced an advert that has been distributed to HRUBA pastors and local churches and posted on the HRUBA website. It has also been posted on the website of the Canadian Association for Baptist Freedoms and sent to the CABF office, to Acadia Divinity College and to the executive of the African United Baptist Association.

The closing date for the present advert is January 7, 2022 and the Personnel Sub-Committee will meet on January 11, 2022 to review applications. Finalization of the interview panel and interview questions is underway, with the expectation of interviews being scheduled for the end of January or early February, 2022. Respectfully submitted,

### **Baptist Chaplain at Dalhousie Report**

For the 2021 Fiscal Year

HRUBA is fortunate to have another year of service from Lic. Arla Johnson. Arla is the Chaplain on duty at DAL University.

A brief **introduction** to the current DAL Chaplain, Arla Johnson:

•Arla is a member of First Baptist Church Halifax (FBCH)

•Arla is a Deacon at FBCH (previously she was on the Deacon Executive)

•Arla is a graduate of Atlantic School of Theology (AST)

•Currently Arla is working with Rev. Dr. Marjorie Lewis (Acadia University Chaplain), and Rev. Dr. Rusty Edwards (Senior Minister at FBCH), who are acting as her coaches while she works toward her licensing for ministry.

•Working with Rev. Rick Gunn (Minister at St. Luke's United Church), they have organized and founded Queer Spirit Church Halifax. Queer Spirit Church delivers a monthly service, that takes place at FBCH. The monthly inclusive service occurs the first Wednesday of each month, with focus for inclusively queer communities. The Queer Church also supports a Queer Theology Group. (Presently, all services are provided via Live Stream.) •Arla is a proprietor of an active and successful business in Halifax.

Arla makes herself available on **Tuesday mornings**. Just as COVID has challenged may businesses, and many jobs, and many church services, Arla's support for DAL students has also been challenged – she has been unable to meet face-to-face with students.

Arla has **plans for the future**: Arla plans to work with others on the DAL religious support team to discuss and plan how to promote her on-line availability, service times, and ways to include students at services/resources outside of DAL that may be of interest to them. Arla also plans to include DAL students in the Monday night community meal at FBCH and the Wednesday night (on-line Queer Spirit Church service). Arla is aware there is a '*line-up*' of students requesting counselling. She is a registered therapist; therefore, she wonders if she can be of assistance in this area. Arla believes this may be another way of making contact with students, supporting them in counselling, and where appropriate, inform them of the support she also provides in chaplaincy. Arla wants to be as valuable and useful a resource as possible, and where possible at DAL; and sometimes this means reaching outside of her chaplaincy role, to complement her chaplaincy role – all in the best interest of the students.

Arla's experiences outside of DAL Chaplaincy reach far-and-wide and when COVID restrictions are lightened in the coming year, she will make more contacts and more invitations will be extended to students.

### **Bayside Camp and Retreat Centre Report**

For the 2021 Fiscal Year

2021 was a wild ride at camp! After 2020 saw our first season in over 65 years where we did not run overnight camp programs, we were doing our best to imagine a summer season despite the ongoing pandemic. We planned and planned! Many thanks to our summer staff team and camper families who waited in limbo for the status of our overnight camp season for over 4 months!



Things looked promising in April and so we launched registration and organized our staff team . However we did not have an official go-ahead or guidelines until just 8 days prior to our staff training launch! Thankfully, at that point our plans were set and only required very small changes to fit with the guidelines and so we were off!

We felt very blessed to host 7 weeks of overnight camps with a total of 342 campers, including 10 Core leaders! Our staff team rose to the occasion and provided the best possible experience despite the limitations of cohorts and distancing requirements.

Normally our calendar outside of summer would be full, however 2021 was very modest, only hosting 4 groups all year. Despite these setbacks we have had a positive financial year with government programs offsetting a significant portion of staff wages and some of our insurance overhead.

Please pray for camp as we navigate the path forward. We now only have myself on staff (down from 4 total previously) and we are in the midst of launching a capital campaign. It will be a difficult few years both financially and operationally as we pursue God's vision for what Bayside can offer our community.

As we look to 2022 there are many unknowns but we are hoping and planning for a season of overnight camps and look forward to the story that God will continue to write through the ministry at Bayside.

### **Constitution Committee Report**

For the 2021 Fiscal Year

In late 2020, the Constitution Committee circulated the draft amendment to our By-Laws to member churches and asked for comment by early 2021. Also circulated was Notice of Motion for a Special Resolution to repeal By-Law #1 and replace it with By-Law #2 at the April 20, 2021 Meeting of the Association Body of Delegates. There were no concerns raised.

At the Annual Meeting held by Zoom, the Special Resolution was passed with a large majority. The Amendment package was sent to the Office of the Registrar and was approved by the Registrar on September 27, 2021. The new By-Law #2 is now available on the HRUBA Website (see <u>Halifax Region United Baptist Association – Our Governing Documents (hruba.ca</u>).

Since then, the Constitution Committee has continued work on updating the Policy and Procedures Manual, making it consistent with the changes in the By-Laws and adding detail. The updated manual was adopted by the HRUBA Council at its meeting on June 1, 2021 and is now also available on the HRUBA Website. A motion to ratify the decision of the HRUBA Council to adopt the update will be made at the 2022 Annual Meeting of the Association Body of Delegates.

Work continues on updating and adding detail to several sections of the Policy and Procedures Manual and the committee continues to offer advice on governance issues to the HRUBA Executive and Council when new issues arise.


